Minutes of the **Allotment Advisory Committee** held on Monday **16**th **March 2015** in Messingham Village Hall commencing at 7.00pm.

473. APOLOGIES FOR ABSENCE

Received from Councillors J McKellar Main, Mrs J Briggs, T Foster and J England.

474. DECLARATIONS OF INTEREST – None received.

475. MINUTES OF LAST MEETING 19th January 2015

The minutes were circulated to all members prior to this meeting. They were agreed to be a true record. Adopted by the Parish Council on 9^{th} February 2015 – Min. 1173/131.

476. MATTERS ARISING

a) Min 467d Rabbit Control

The Clerk apologised for not having spoken to Richard Benson on this matter and agreed to do so promptly.

b) Min 470a Allotment 44aa – New Tenant

It was noted that the tenant, Mr Atkin, has had soil delivered to raise the beds which has encroached another plot and has been left flattened by the digger which brought it. The Clerk reported that she had contacted the tenant and they have assured her that any surplus soil will be used on their own plot and brought to a high standard. It was agreed that the supply of additional soil is in breach of Rule 2 and the tenant to be advised not to take any more. The subject of insurance for the use of a machine on the allotment was debated and it was suggested that third party liability insurance should be the minimum requirement.

c) Min 467a Allotment 44aa – Rubbish Removal

It was agreed that a mini skip be hired on 20th March for the removal of the broken slabs and carpet etc. Mr Chapman and Mr Ross agreed to fill the skip and it was agreed that they could claim expenses for their time.

d) Min 470b Emma Botfield

Following Mr Barley's agreement to terminate the tenancy of Allotment 40a/b, Mrs Botfield inspected the plot and advised that it was not suitable for her needs. The Clerk subsequently allocated Allotment 11c to Mrs Botfield which had been officially terminated by Mrs Mitchell. Mr Barley has subsequently agreed to continue the tenancy of 40a/b until further notice. Mr M Walker commented that he accompanied Mrs Botfield to 11c to advise as required but noted that little work had been carried out to date.

e) Min 471a & b Untidy Notices

The Clerk apologised for not having sent the untidy notices due to an oversight. List to be reviewed.

f) Min 472b Tenant Letter

The Clerk circulated a draft letter to be sent to all tenants with the rent notices. This was approved.
