72. MATTERS REFERRED FROM PARISH COUNCIL – None referred not covered in agenda.

### 73. HOLME MEADOW

- a) HORSE FOULING reported after the SDPOC Wednesday Night Games. Agreed to contact SDPOC to advise that this level of fouling is unacceptable.
- b) DOG OWNERS NOTICE sign damaged as previously reported.
- c) BOTTOM DYKE still waiting to be cleared by Mr Ross and the handyman. Agreed that this should be the responsibility of the landowner, Mr Foster Thornton but it was noted that he never responds to correspondence on this matter. It was agreed to take advice from ERNLLCA with regard to any liability for doing the work and/or passing the cost to the landowner.
- d) FERTILISER not done since 2014 agreed to obtain price from Glendale.
- e) DEEP TINING of Pitch One agreed to be required as soon as possible. To be referred to Parish Council for approval.
- f) WEED SPRAYING of whole field required agreed to obtain price from Glendale.

## 74. PLAY AREA

It was noted that Mr J Dudley, has offered his services to either assist or maintain specific areas. It was agreed that the Clerk will discuss the workload with the handyman with a view to splitting the areas of responsibility.
