Minutes of the **Parish Council** meeting held on Monday **9**th **September 2013** in Messingham Village Hall commencing at 7.15pm.

65. POLICE MATTERS

The monthly crime statistics had been received from PC Teale and circulated to all members. There were no further issues.

67. MINUTES OF LAST MEETING 12th August 2013

The minutes were circulated to all members prior to this meeting. They were agreed to be a true record and duly signed by the Chairman.

68. MATTERS ARISING

a) Min 51a Dogs on Leads Signs

The Clerk reported that Holy Trinity Church have agreed to pay for one sign but that the Playing Field committee have yet to meet to discuss the matter. It was noted that one sign has been produced and is ready to be erected at the church entrance gate.

b) Min 51b MUGA Questionnaire

It was noted that of the 1500 questionnaires delivered, 175 replies had been received by the closing date of 31st August (109 paper questionniares and 66 online surveys) with all but one in favour of the provision of a MUGA. It was agreed that a MUGA Sub Committee be formed and Councillors Poole, McKellar Main, Wright, Clark and Mountain offered to be involved and it was further agreed that three members of the public be elected from an arranged meeting of the 37 people who indicated a desire to help.

There were 127 entries into the Prize Draw – the Chairman made the draw and the first name drawn was Mr & Mrs P Wright but Councillor Wright declined to accept the prize and the draw was done again with the winner being Mr D W Briggs (Councillor Mrs Briggs stated that he was not a relation).

c) Min 51c Floodlight Damage

The Clerk reported that a response had been received from Lytec acknowledging receipt of the Parish Council letter and stating that a full response will be sent in due course.

d) Min 51d Overhanging Trees Ashlin Court

Copy correspondence from Mr Fisher to resident of Ashlin Court for information only. Noted.

e) Min 54a/4 Complaint from Mrs Brown

The Clerk reported that the following the advice from ERNLLCA that an independent advisor, be appointed to consider the facts of the complaint, Mr Gareth Roberts was recommended who has offered to carry out the work at a reduced rate of £30 per hour plus mileage cost of 45p per mile. As the number of hours required is unknown it was not possible to set a budget but it was agreed to engage Mr Roberts and to write to Mrs Brown to inform her of this fact.

f) Min 54c Village Hall Charges

The Clerk produced copies of previous years charges and it was noted that all parties have received the same percentage increase.

g) Min 55c Church Photograph in Local Press

It was noted that the photograph has been updated in the Scunthorpe Telegraph.

69. MINUTES OF LEISURE & RECREATION COMMITTEE 19th August 2013

A site visit had taken place and six dead/dying trees agreed to be removed. It was agreed to get quotes for this and to also price up replacement mature trees (6-8' tall).

Noted that the consultation is ongoing with afternoon only restrictions being considered. Agreed to contact I Jickells and G Denovan at NLC for an update on the situation.
- c) WEST GREEN/SCHOOL DRIVE SNICKET Standing water on footpath considerably worse since last repairs done to the surface. To be referred to Highways.
- d) ASHBERRY DRIVE lamppost no. 3 close to the roundabout appears to be leaning. To be referred to Highways.
- e) CHESTNUT DRIVE/SCOTTER ROAD SNICKET query regarding responsibility for cleaning the footpath from resident Mr P Grout to be referred to Neighbourhood Services for clarification of ownership.
