6 members of the public: Mrs H Collins, Mr D Appleyard, Mr P Hafford, Mrs S Trevethan, Mr T Hutson, Mrs E Botfield, all individually addressed the meeting to emphasise their concerns regarding noise and parking effects on the neighbouring residential areas.

### 114. DECLARATIONS OF INTEREST

PA/2016/1603 Councillor J McKellar Main declared a prejudicial interest.

PA/2016/1603 Councillors N Poole, T Foster and J England declared their personal interests as they have been lobbied as NLC Councillors.

PA/2016/1603 Councillor T Foster declared his personal interest as he is known to the applicant.

The Chairman proposed that Planning be brought forward on the Agenda due to the number of public present. Agreed.

### 115. PLANNING

### a) Planning Decisions by NLC

- 1. 2016/867 Lincolnshire Co-operative Messingham relocate existing totem sign APPROVED
- 2. 2016/1518 Northern Powergrid Northfield Road Aerial bunched conductor APPROVED

### b) Planning Applications before NLC:

Councillor J McKellar Main left the room prior to discussion of the following planning application;

- 2016/1603 Krajnik, Rear of 68 High Street conversion of barn and outbuildings to create a new wedding venue and bridal suite with associated landscaping and car parking. Letters of objection were read out from Mr & Mrs Appleyard and Mr McKellar Main. Following lengthy discussion it was agreed to OBJECT to this application for the following reasons;
  - In support of residents objections with regard to **light nuisance** to neighbouring properties which are not realistically addressed within the Lighting Plan these include the car park, the outside areas and the venue itself.
  - In support of residents objections with regard to **noise nuisance** to neighbouring properties which are not realistically addressed within the Noise Plan these include noise from music and guests from within the venue; noise from the car park as vehicles leave up to 2am; and noise from any fitted extraction fans or air conditioning units.
  - In support of residents objections with regard to **parking issues** which are not realistically addressed within the Travel Plan these include the small number (32) of spaces for a venue

that can cater for up 240 people plus staff; the likelihood for vehicles to park outside the venue when the car park is full i.e on the High Street (the A159 Scunthorpe to Gainsborough road) or in adjacent streets i.e. Brigg Road, Butterwick Road both of which are very busy junctions with High Street; the Stables Restaurant which is located alongside the proposed venue has a small car park which will be required for patrons of the restaurant – this again will increase the likelihood of parking on the High Street. The High Street already hosts four licensed premises which create on street parking issues in evenings and weekends.

- In support of residents objections with regard to **loss of amenity** due to the proposed venue being in the centre of a densely populated residential area for the reasons listed above.
- Concerns that the access to the venue will be through the car park of the Stables Restaurant
  which is also bordered by an agricultural building used for storage of vehicles both of these
  businesses create traffic movement from and to the busy A159. It is assumed that wedding
  guests and restaurant patrons will both be using the Stables car park at the same time,
  particularly on Saturday evenings this would be chaos in itself.

### The meeting was suspended while the majority of the public left the room
