This website is run by Messingham Parish Council. We want as many people as possible to be able to use this website. For example, that means you should be able to:

## Technical information about this website's accessibility

Messingham Parish Council is committed to making its website accessible, in accordance with the Public Sector Bodies (Websites and Mobile Applications) (No. 2) Accessibility Regulations 2018.

## Disproportionate burden

Our accessibility evaluation is based on a basic check as we believe that, given the size and relative simplicity of our website, the cost of an external audit would place a disproportionate burden on the Parish Council.

## Content that's not within the scope of the accessibility regulations

PDFs and other documents

Many of our older PDFs may not meet accessibility standards - for example, they may not be structured so they're accessible to a screen reader. [See WCAG 2.2 success criterion 4.1.2 \(name, role value\)](#).

The accessibility regulations do not require us to fix PDFs or other documents published before 23 September 2018 if they're not essential to providing our services. For example, we do not plan to fix agendas and minutes published before that date.

Any new PDFs we publish will meet accessibility standards.

This website was last tested on 03-Sep-2020. The test was carried out by manual and automated means by Kyanite Consulting Limited.
